This product contains: Colloidal gold particles in 0.1mM Phosphate Buffered Saline with a citrate surface.

Component 1: Water, >99% (w/v), CAS 7732-18-5

Component 2: Gold, <0.1% (w/v), CAS 7440-57-5

Component 3: Citrate, <0.001% (w/v), CAS 6132-04-3

3. Hazards Identification

Emergency overview: Harmful if swallowed, contact with skin and by inhalation.
