3. COMPOSITION/INFORMATION ON INGREDIENTS

Pertussis toxin from *Bordetella pertussis*. Sample is of biological origin and is presented as a liquid in a plastic vial.

Additional components present: 0.05M sodium phosphate buffer at pH7.2 and 0.5M sodium chloride.

4. FIRST AID MEASURES

If inhaled: If breathed in, move person into fresh air. If not breathing give artificial respiration.

In case of skin contact: Wash off with soap and plenty of water. Consult a physician.

In case of eye contact: Rinse thoroughly at eyewash station for at least 15 minutes and consult a


