3. COMPOSITION/INFORMATION ON INGREDIENTS

Rubella nucleoprotein is expressed recombinantly in a mammalian cell expression system. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: 20mM TRIS-HCl pH8.0, 50mM NaCl, 0.5% SDS.

If swallowed: No treatment required




