Recombinant Borrelia ErpD/Arp37 protein is expressed recombinantly in an E. coli expression system. Sample is of biological origin and is presented as a liquid in a plastic vial. Each vial contains no more than 1000µg.

Additional components present: 0.02~M Potassium Phosphate, 0.15~M Sodium Chloride, pH 7.2 and 0.01% (w/v) Sodium Azide
